The contract will be approved for a period not to exceed more than one (1) year and with the understanding that the contract can be terminated per paragraph 8 before then. It is a requirement of the Michigan Safe Drinking Water Act (Act 399) to have a Water Supply Operator in charge. In addition, authorize the Mayor and City Clerk to sign the contract on behalf of the City, as outlined in 8-A. Per Mayor Bazzi communication dated June 24, 2021.
