23-277 Motion by Councilman Muscat, seconded by Councilwoman Bryer to adopt the Resolution of the Council of the City of Dearborn Heights, Michigan adopting an operating budget for the Fiscal Year beginning July 1, 2023 and ending June 30, 2024, as outlined in 11-A.

After further discussion, the motion was amended to reflect the following:

Motion by Councilman Muscat, seconded by Councilwoman Bryer to adopt the proposed tax levy for the fiscal year beginning July 1, 2023 and ending June 30, 2024, and said tax levy shall be composed of the constituent rates, for the purposes, and with estimated yields described as follows based upon an aggregate of Taxable Assessed Values of \$1,639,183,665.00 for the City of Dearborn Heights or as may be subsequently certified and amended net of tax increment capture, as outlined in 11-A.
