17-081 Motion by Councilwoman Hicks-Clayton, seconded by Councilman Abdallah, to refer the conversion of the City's street lights to LED to a Study Session for further discussion with Debra Cain of DTE Energy, Mayor Paletko, Public Service Administrator Zimmer, Community and Economic Development Director Hachem and Treasurer Riley. Per Mayor Paletko, communication dated March 7, 2017.

17-082 Motion by Councilman Muscat, seconded by Councilman Kosinski, to approve the request from Crestwood High School to hold their 5K Color Run on Sunday, April 23, 2017 at 10:00 a.m. Per Mayor Paletko, communication dated March 6, 2017.

17-083 Motion by Councilman Muscat, seconded by Councilwoman Hicks-Clayton, to approve the request from St. Sebastian Parish to hold their 2017 Spring Festival Parade for Saturday, May 20, 2017 at 11:00 a.m. Per Mayor Paletko, communication dated March 6, 2017.

17-084 Motion by Councilman Kosinski, seconded by Councilman Abdallah, to concur with Administrative Assistant Laslo and approve the closing costs for 23410 Hanover and 23470 Hanover for a total amount for each property not to exceed \$2,500.00 plus taxes. 17-085 Motion by Councilman Kosinski, seconded by Councilman Abdallah, to concur with Administrative Assistant Laslo and authorize the demolition by McMillan Group, Inc. of the property at 23530 Hanover per the quote of \$12,525.00. Per this contract, the structures are to be demolished and brought back to grade by April 15, 2017. This motion further approves the contract with McMillan Group, Inc. that has been reviewed by Assistant Corporation Counsel Harry Kalogerakos and authorizes the Mayor and City Clerk to sign the contract on behalf of the City. Per Administrative Assistant Laslo, communication dated March 7, 2017.

17-086 Motion by Councilman Kosinski, seconded by Councilwoman Hicks-Clayton, to concur with Community and Economic Development Director Hachem and authorize Change Order No. 1 and payment to Rochester Hills Contract Glazing in the amount of \$42,995.00 for the FY 2015 CDBG Berwyn Improvements CEDD Window Project. The original contract amount was \$42,600.00. This motion further authorizes the Comptroller and Treasurer to issue the check and return the check to the CEDD Office. Per Community and Economic Development Director Hachem, communication dated March 2, 2017.

- 17-087** Motion by Councilman Muscat, seconded by Councilman Kosinski, to agree with Public Service Administrator Zimmer and approve Change Order No. 12 from Lanzo Lining Inc. for sewer lining services at various locations throughout the City at no cost increase. The total cost for this year's projects are not to exceed \$250,000.00. Funds for this program have been allocated in the approved 2016-2017 Water Budget. Per Public Service Administrator Zimmer, communication dated March 1, 2017.

- 17-088** Motion by Councilwoman Hicks-Clayton, seconded by Councilman Kosinski, to concur with Police Chief Gavin's request and enter into the maintenance agreement with PM Technologies for the Justice Center generator for an annual fee of \$2,150.85. This expenditure will come out of the Contractual Services Account with \$1,398.05 to be paid by the Police Department and \$752.80 to be paid by the 20th District Court.

After a discussion concerning the pricing and terms of the agreement, the following motion was offered:

- 17-089** Motion by Councilwoman Hicks-Clayton, seconded by Councilman Muscat, to amend the original motion and refer the maintenance agreement with PM Technologies back to Police Chief Gavin for further research, clarification and pricing options. Per Police Chief Gavin, communication dated February 21, 2017.

- 17-090** Motion by Councilwoman Horvath, seconded by Councilman Muscat, to approve payment to Motorola in the amount of \$57,830.64 for the annual service agreement that covers MCC7500 radio consoles and the Intrado VIPER telephone system. This expenditure will come out of the Police Contractual Services Account. Per Police Chief Gavin, communication dated March 1, 2017.

- 17-091** Motion by Councilman Muscat, seconded by Councilwoman Hicks-Clayton, that Proposed Ordinance H-17-01, formerly Proposed Ordinance H-16-07, AN ORDINANCE OF THE CITY OF DEARBORN HEIGHTS, PROVIDING THAT THE CODE OF ORDINANCES, CITY OF DEARBORN HEIGHTS, BE AMENDED BY ADDING A NEW ARTICLE XI UNDER CHAPTER 7 WHICH SHALL BE COMPOSED OF NEW SECTIONS 7-801 THROUGH 7-809 CONCERNING THE INSTALLATION AND MAINTENANCE OF GREASE INTERCEPTORS AS WELL AS DISCHARGE PROHIBITIONS REGARDING SAID GREASE INTERCEPTORS, be considered read for the second time and become effective upon publication.

A discussion ensued regarding the penalties for multiple offenders of the Grease Interceptors Ordinance. Corporation Counsel Miotke stated that the ordinance could be changed to include additional fines. The following motion was offered:

- 17-092** Motion by Councilman Muscat, seconded by Councilman Abdallah, to approve Proposed Ordinance H-17-01 with the following language, drafted by Corporation Counsel Miotke, added under Section 7-808 (a):

Any property owner or operator of an establishment who violates any provision of this article shall be responsible for a municipal civil infraction punishable by a fine in the amount of \$500.00 for a first offense, a fine of \$1,000.00 for a second offense within a one-year period and a fine of \$1,500.00 for a third or subsequent offense within a one-year period.

This motion further considers Ordinance H-17-01 read for the second time and becomes effective upon publication.

- 17-093** Motion by Councilman Muscat, seconded by Councilwoman Hicks-Clayton, to adopt a Resolution to Oppose Sale and Development of Warren Valley Golf Course. This motion further authorizes the City Clerk to distribute copies as outlined in the resolution. Per Councilman Muscat and Councilwoman Hicks-Clayton, communication dated March 7, 2017.

- 17-094** Motion by Councilman Kosinski, seconded by Councilman Muscat, to adopt a Resolution Authorizing Mayor and Corporation Counsel to Enter into Negotiations Relative to the Possible Purchase of Warren Valley Golf Course and Surrounding Properties.

Motion adopted.

- 17-095** Motion by Councilwoman Hicks-Clayton, seconded by Councilman Muscat, to adopt a Resolution Prohibiting the Selling of Products and/or Services on the Grounds of the Canfield Community Center during the 2017 Spirit Festival on June 7, 2017 through June 11, 2017 unless prior approval is granted by the Spirit 2017 Festival Committee. This motion includes the area of Beech Daly Road that runs parallel with the Festival grounds. Per Recreation Director Grybel, communication dated March 6, 2017.

Motion adopted.

- 17-096** Motion by Councilman Kosinski, seconded by Councilman Abdallah, to agree with Public Service Administrator Zimmer and approve the MDOT Cost Agreement and the Resolution Approving the Michigan Department of Transportation (MDOT) Cost Agreement for Traffic Signal Control at US-12 (Michigan Avenue) at Gulley Road. Attorney Mark Roberts has reviewed this documentation. This motion further authorizes the Mayor to sign the MDOT Cost Agreement and the City Clerk to sign the Resolution on behalf of the City. Per Public Service Administrator Zimmer, communication dated March 6, 2017.

- 17-097** Motion by Councilwoman Horvath, seconded by Councilman Muscat, to approve the business license renewals Famous Auto Center, 25996 Van Born, and Ford Lanes Inc., 23100 Van Born, and, at the City Clerk's request, remove the business license renewal for Red Lobster Hospitality LLC, 6850 N. Telegraph.
