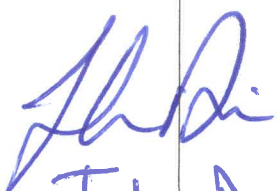

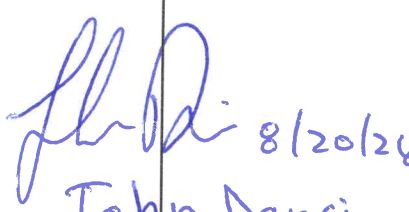

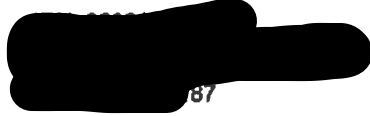

WHEREAS Act 416 Public Acts of 1978 enables each Sheriff's Office to provide patrol and monitoring of traffic violations, investigation of accidents involving motor vehicles, and emergency assistance to persons on or near "county primary roads, county local roads, and state trunk line highways" within city limits; and

WHEREAS One of the requirements for a municipality to receive the services of a Sheriff's Office is for the legislative body to pass a resolution requesting the service under Act 416, P.A. 1978; and

WHEREAS The services provided under law include patrolling and monitoring traffic violations, investigating accidents involving motor vehicles, and providing emergency assistance to persons on or near a highway or road patrolled and monitored; and

WHEREAS By the City Council of the City of Dearborn Heights that such service authorized under Act 416, P.A. 1978 be determined to be beneficial to the City and can provide for more efficient enforcement of State Statutes and Local Laws;

NOW THEREFORE BE IT RESOLVED That the Wayne County Sheriff's Office be requested to provide the following services: patrolling and monitoring traffic violations, investigating accidents involving motor vehicles, and providing emergency assistance to persons on or near all "county primary roads and county local roads and state trunk line highways" within the City of Dearborn Heights.

**INTERGOVERNMENTAL AGREEMENT BETWEEN
THE CITY OF DEARBORN HEIGHTS AND
THE COUNTY OF WAYNE**

THIS AGREEMENT ("IGA") is between the County of Wayne, Michigan, a body corporate, and Charter County, acting through its Wayne County Sheriff's Office ("WCSO" or the "County"), and the City of Dearborn Heights (the "City")

WHEREAS, the City will benefit from the assistance to its Department of Police by officers of the Wayne County Sheriff's Office issuing citations for traffic and criminal violations set forth in certain City Ordinances; and

WHEREAS, the assistance rendered to the City's Department of Police by the officers of the Wayne County Sheriff's Office in issuing citations to enforce traffic and criminal laws set forth in certain City Ordinances may produce tangible benefits for the City, including revenues collected and protection of city streets and roadways from violations of those Ordinances;

IT IS AGREED:

In consideration of the foregoing recitals and mutual covenants contained herein, and other good and valuable consideration set forth in this Agreement, it is mutually agreed as follows:

1. The officers of the Wayne County Sheriff's Office are hereby authorized to issue citations for violations of City Ordinances, including traffic laws and criminal offenses, that have occurred on the streets and roadways within the corporate boundaries of the City.
2. That City Ordinances for which the officers of the Wayne County Sheriff's Office are authorized to issue citations, as set forth in the City of Dearborn Heights Code of Ordinances, shall include, but not be limited to, Chapter 20, titled "Offenses," and Chapter 32, titled "Traffic and Motor Vehicles," as amended:
 - A. licensing, registration, and insurance;
 - B. equipment;
 - C. operation and accidents;
 - D. offense against governmental functions;
 - E. offenses against the person;
 - F. offenses against the public peace;
 - G. offenses against property;

- H. offenses against the public safety;
 - I. offenses against the public morals;
 - J. offenses involving minors; and
 - K. such other Ordinances as the City and County Sheriff's Office may, from time to time, agree upon.
3. When deemed necessary by the City of Dearborn Heights Prosecutor or pursuant to a court order, officers of the Wayne County Sheriff's Office shall appear at all court dates related to citations they have issued under this Agreement. The City will not be responsible for compensating an officer for their appearance.
4. **Compensation:** Revenue from the issuance of citations shall be divided as follows:
- A. The Wayne County Sheriff's Office shall be entitled to receive fifty percent (50%) of the revenue collected from citations issued by its officers, including any infractions reduced by the Court to non-moving citations, within the corporate boundaries of the City, after deducting mandatory fees payable to the State of Michigan
 - B. The Municipality shall be entitled to collect the entire revenue. The Municipality shall retain fifty percent (50%) of the revenue collected from citations issued by officers of the Wayne County Sheriff's Office, including any infractions reduced by the Court to non-moving citations within the corporate boundaries of the City, after deducting mandatory fees payable to the State of Michigan, and remit fifty percent (50%) of the revenue to the Wayne County Sheriff's Office pursuant to Paragraph 4 above.
 - C. The revenue collected from citations issued by the officers of the Wayne County Sheriff's Office and paid to the Municipality of Dearborn Heights shall be allocated to the City's general fund or to such other account as the City may designate.
 - D. "Revenue collected from citations" shall mean fines only, not costs assessed, such as probation, work programs, or court costs.
5. **Term & Termination:** This Agreement begins upon Commission approval and ends ten years later. Either party may, within its sole discretion, discontinue the assistance rendered under this Agreement at any time upon forty-eight (48) hours' written notice to the Mayor of the City or the Wayne County Sheriff. After receipt of a Notice of Termination, each party will assist the

other party in the orderly termination of this Agreement and the transfer of all tangible or intangible assets as may be necessary for the orderly, uninterrupted business continuance of each party.

6. A Resolution adopting the terms and conditions of this Agreement shall be passed by the City's legislative body, i.e., the Dearborn Heights Council, or by the person authorized to act as such, prior to this Agreement taking effect, and shall become a part hereof.
7. **Limitations on Liability:** The following terms and conditions will apply to instances of liability, loss, and damage:
 - A. The City shall assume full responsibility for the actions of its employees, personnel, and/or agents acting pursuant to this Agreement with respect to liability. All liability, loss, or damage resulting from claims, demands, costs, or judgments arising out of activities carried out pursuant to the City's obligations under this Agreement are the City's responsibility, not the County's, if the liability, loss, or damage is caused by, or arises out of, the actions or failure to act on the part of the City, any of its departments, or anyone directly or indirectly employed by the City. This section is not to be construed as a waiver of any governmental immunity the City, its agencies, or employees have as provided by statute or modified by court decisions.
 - B. The County shall assume full responsibility for the actions of its employees, personnel, and/or agents acting pursuant to this Agreement with respect to liability. All liability, loss, or damage resulting from claims, demands, costs, or judgments arising out of activities carried out pursuant to the County's obligations under this Agreement are the responsibility of the County and not the City's if the liability, loss, or damage is caused by, or arises out of, the action or failure to act of any County employee or agent. This section is not to be construed as a waiver of any governmental immunity the County, its agencies, or employees have as provided by statute or modified by court decisions.
 - C. If liability to third parties, loss, or damage arises from activities conducted jointly by the parties in fulfilling their responsibilities under this Agreement, the liability, loss, or damage must be borne by the parties in proportion to each party's responsibilities for those joint activities. This section is not to be construed as a waiver of any governmental immunity by the parties, their agents, or their employees. Each party has a duty to mitigate damages for which the other party is responsible.

- D. For purposes of these provisions, the term "County" includes the County of Wayne and all other associated, affiliated, or subsidiary departments or divisions, now existing or to be created, and their agents and employees.

8. **No Assignment:** Neither party may assign this Agreement or any part of it, nor subcontract any of the work or services to be performed, without the other party's prior written approval.

9. **Confidential Information:** If either party discloses confidential information to the other's employees regarding past, present, and future activities, the party must instruct its employees to regard all information obtained by each employee as a result of the services to be performed as confidential and not to be disclosed to any organization or individual without the prior written consent of the disclosing party.

10. **Compliance with Laws:** Each party must comply with all applicable laws and regulations and must require its employees to do so.

11. **Non-Discrimination Practices:** Each party must comply with:

- A. Titles VI and VII of the Civil Rights Act (42 U.S.C. §§2000d et seq.) and the United States Department of Justice (28) CFR Part 42, Issued pursuant to those Titles.
- B. The Age Discrimination Act of 1985 (42 U.S.C. §6101-07).
- C. Section 502 of the Rehabilitation Act of 1973 (29 USC. §794).
- D. The Americans with Disabilities Act of 1990 (42 U.S.C. §12101 et seq.) and its associated regulations.
- E. The Michigan Civil Rights Act (P.A. 1976, No. 453) and the Michigan Persons with Disabilities Civil Rights Act (P.A. 1976 No. 20 as amended by P.A.No. 20 of 1998).

12. **Records-Access:** Each party must maintain records subject to the following conditions:

- A. Each party must maintain complete books, ledgers, journals, accounts, or records in which it keeps all entries reflecting its operations pursuant to this Agreement. Each party must keep the records in accordance with generally accepted accounting practices.
- B. Each party must retain all records for at least 3 years after the Agreement's termination and completion.

13. **Relationship of the Parties:** The parties are independent contractors. No liability or benefits, such as workers' compensation, pension rights, or insurance rights, arising out of or related to a contract for hire or an employer/employee relationship, accrue to either party or to either party's agent, subcontractor, or employee because of this Agreement. No relationship, other than that of independent contractor, will be implied between the parties or between either party and its agent, employee, or subcontractor.
14. **Insurance:** During the term of this Agreement, each party is required to maintain insurance subject to the following terms and conditions:
- A. Each party, at its expense, must maintain during the term of this Agreement of the following insurance or self-insurance plan
 - 1) Professional liability insurance with minimum limits of \$1 Million Dollars per occurrence and \$1 Million Dollars aggregate.
 - 2) Workers' Compensation Insurance which meets Michigan statutory requirements.
 - 3) "Commercial General Liability" Insurance endorsed to include contractual Liability, with minimum limits of liability of \$2 Million Dollars for bodily injury and property damage, per occurrence, and with a minimum of \$2 Million Dollars for bodily injury and property damage, in the aggregate.
 - 4) Comprehensive Automobile Liability (including hired and owned vehicles) with minimum limits for bodily injury of \$1 Million Dollars per occurrence and with minimum limits for property damage of \$500,000 per occurrence.
 - B. If, during the term of this Agreement, changed conditions or other pertinent factors render inadequate the insurance limits, each party will furnish on demand such additional coverage as may reasonably be required and available under the circumstances. The insurance must be effected under valid and enforceable policies issued by recognized, responsible Michigan insurers that are well rated by national rating organizations.

15. **Notices:** Each party shall abide by the following terms and conditions relative to communications

A. All notices, consents, approvals, requests, and other communications ("Notices") required or permitted under this Agreement must be given in writing and mailed by first-class mail, addressed as follows:

B. All notices are deemed given on the date of mailing. Either party to this Agreement may change its address for notices at any time by giving notice to the other party as provided herein. Any notice given by a party must be signed by an authorized representative of that party.

C. Termination notices, change-of-address notices, and other legal notices are exceptions and must be sent by registered or certified mail, postage prepaid, return receipt requested.

16. No failure by a party to insist upon the strict performance of any term of this IGA or to exercise any right after a breach shall constitute a waiver of any breach of said term. No waiver of any breach affects or alters this IGA, but every term of this IGA remains effective with respect to any other then existing or subsequent breach.

17. If any provision of this Agreement, or its application to any person or circumstance, is, to any extent, judicially determined to be invalid or unenforceable, the remainder of the Agreement, or the application of the provision to persons or circumstances other than those as to which it is invalid or unenforceable, is not affected and remains enforceable.

18. **Jurisdiction:** This Agreement and all actions arising from it must be governed by, subject to, and construed under the laws of the State of Michigan. Each party consents to the personal jurisdiction of any competent court in Wayne County, Michigan, for any action arising out of this Agreement. Service of process at the address and in the manner specified in this Agreement will be sufficient notice. Neither party will commence any action against the other arising out of or relating to the validity, construction, interpretation, or enforcement of this Agreement in any court other than those in the County of Wayne, State of Michigan, unless the original jurisdiction is in the United States District Court for the Eastern District of Michigan, Southern Division, the Michigan Supreme Court, or the Michigan Court of Appeals.
19. Both parties agree not to commence any action or suit relating to the Agreement more than 6 months after the date of termination and to waive any statute of limitations to the contrary.
20. **Authorization and Capability:** The City warrants to the County that it has taken all actions necessary to authorize, execute, deliver, and perform this Agreement. It is ready to perform its obligations. The City further warrants that the person signing this Agreement is authorized to do so on behalf of the City and is empowered to bind the City to this Agreement.
21. There are no other agreements, written or oral, between these parties regarding the same subject matter. Any changes or modifications to the Agreement must be in writing and executed by authorized agents of each party.

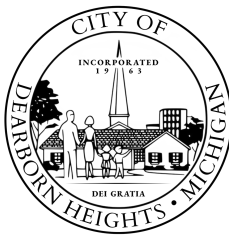
